

**S'pore Tidbits 365 Contest Official Terms & Conditions
(Online Contest)**

TO ENTER: To enter the contest, each participant must submit their photo or video entries online via www.sgtidbits365.sg (the "Website") or <http://www.facebook.com/pages/SDC-SG-Tidbits-365/158660218887> (the "Facebook Page")

Submit photo(s) or video(s) entry based on the theme "My Singapore Tidbits". **There are no limits to the number of entries a participant can submit with one account.**

The contest begins on **9th October 2009** at **12:00am** Singapore time and submission date ends on **31st December 2009** at **11:59pm** Singapore time. All entries must be received no later than the deadline of **11:59 PM** on **31st December 2009** in order to be eligible for selection.

JUDGING CRITERIA:

Percentage of Score	
Public Votes	40%
Judges Decision	60%

The winning entries will be judged based on originality and creativity. The decision of the judges shall be final and binding on all aspects of the contest.

WINNER NOTIFICATION: The winners will be notified by e-mail or by phone based on the information provided in his/her registered account.

ANNOUNCEMENT OF RESULTS: Winners and their entries will be posted on the Website on sgtidbits365.sg after 31st December 2009.

1. All contest participants are required to register as a member of the Website and fill in their personal particulars (i.e. name, contact details, NRIC/Passport no.). Any entry with incomplete or invalid details will be disqualified immediately. Each participant is only entitled to a single account, and may not enter the contest using multiple identities. There is no limit for the number of entries online contest participants can submit (video or photo) and vote for.
2. Employees of the S'pore Discovery Centre ("SDC") and their affiliated and subsidiary companies, and any other party involved or associated with any aspect of this contest are not entitled to participate in the contest.
3. Only entries that are original and have not previously been entered by another participant are eligible for entry in the contest. In the event where two entries are similar by two different participants, only the participant who submitted the entry first will be eligible for the contest.

8. Contest entries with content deemed as irrelevant or offensive by SDC will be removed at the SDC's discretion.

Prize winner will need to present documentary proof of identification to collect prize.
